1. About Russian Association for Promotion of Arbitration

The Russian Association for Promotion of Arbitration (the "**RAA**") was founded in April 2013 in Moscow to unite legal practitioners, law firms and academics. The RAA represents broad interests of the business, legal and education communities involved in the alternative dispute resolution in Russia and the CIS.

The main objective of the RAA is cooperation in the development of arbitration in the Russian Federation and the CIS countries, popularizing Russia as a venue for arbitration, promotion of Russian and CIS arbitrators at national and international levels within the arbitration context, as well as the promotion of foreign arbitrators interested in arbitral proceedings, directly or indirectly relating to Russia and the CIS countries.
